Abortion (endorsement) ban? The Ohio Republican Party State Central Committee held a special meeting via Zoom on Friday to consider a resolution that would require the Ohio GOP to determine Republican candidates' stance on abortion before endorsing them and prohibit the party from endorsing anyone who "embraces the killing of any child from conception forward for any reason." Committee member Gloria Kirker successfully offered an amendment to soften that language, saying that it would prevent the Ohio GOP from endorsing either Donald Trump or Ron DeSantis for president, as they each support some exceptions to a complete abortion ban. Eventually, the committee voted to table the resolution and ended the meeting without passing anything.

# FINAL FINDING FOR RECOVERY OF \$47,646 ISSUED AGAINST FORMER HARTFORD INDEPENDENT AG SOCIETY OFFICE MANAGER FOLLOWING THEFT CONVICTION

COLUMBUS – A finding for recovery of \$47,646 was issued Tuesday against the former office manager for the Hartford Independent Agricultural Society, who was convicted of theft and related counts, Auditor of State Keith Faber announced.

The total included additional amounts not ordered as part of Brooke Williams-Browning's restitution and sentence in Licking County Common Pleas Court, after she pleaded guilty to felony counts of theft, forgery, and tampering with records.

The finding was included in a special audit of the Hartford Independent Agricultural Society, which details the investigation into Williams-Browning's' wrongdoing. A copy of the full report is available online via Search Audits.

The Auditor of State's Special Investigations Unit (SIU) and Licking County Sheriff's Office launched a criminal investigation into the matter in February 2020. SIU ultimately determined that Williams-Browning made 265 improper purchases totaling \$37,814 using the Society's credit or debit cards. Auditors also found seven checks totaling \$5,820 that were payable to Williams-Browning or Cash but had no proper public purpose. An additional \$880 in petty cash could not be located, following her arrest.

Williams-Browning was indicted in July 2022 and was sentenced in December 2022 to 30 days in jail and three years of community control, with a possible prison term of 12 months if she violates post-release control terms. She was also ordered to make restitution of \$39,184.69, which she paid prior to her sentencing hearing.

The remaining balance owed as part of Tuesday's finding for recovery is \$8,462.

Since 2019, the Special Investigations Unit has assisted in 104 convictions resulting in more than \$5 million in restitution (see <u>Map of SIU Convictions</u> since January 2019). The team receives hundreds of tips of suspected fraud annually. Tips can be submitted anonymously online or via SIU's fraud hotline at 866-FRAUD-OH (866-372-8364).

The Auditor of State's office, one of five independently elected statewide offices in Ohio is responsible for auditing more than 6,000 state and local government agencies. Under the direction of Auditor Keith Faber, the office also provides financial services to local governments, investigates and prevents fraud in public agencies, and promotes transparency in government.

# FINDING FOR RECOVERY OF \$2,061 ISSUED AGAINST FORMER JEFFERSON TOWNSHIP ADMINISTRATIVE ASSISTANT

COLUMBUS – A finding for recovery of \$2,061 was issued Tuesday against a former administrative assistant for Jefferson Township in Montgomery County, who continued to receive a paycheck after she left the position, Auditor of State Keith Faber announced.

Adrianne Jones resigned effective April 16, 2021, but was paid on a biweekly basis through May 27, 2021, when she no longer was working in any capacity for the Township.

Former Township Administrator Steve Woolf was responsible for ensuring Jones was removed from the Township's payroll, and Township Trustee Mike McLaughlin and former Trustees James McGuire and Roy Mann Sr. approved the payments.

Woolf, McLaughlin, and Mann are jointly and severally liable for \$2,061, while McGuire is jointly and severally liable for \$354.

The Township did not provide an explanation to auditors about the payments.

# SPECIAL AUDIT DETAILS INVESTIGATION, \$43,011 FINDING FOR RECOVERY AGAINST FORMER FISCAL OFFICER OF VILLAGE OF RISINGSUN

COLUMBUS – A finding for recovery of \$43,011 was issued Tuesday against the former fiscal officer for the Village of Risingsun, who was convicted in 2022 of stealing from the Wood County community, Auditor of State Keith Faber announced.

The finding is included in a special audit that outlines the investigation into Robin L. Hindall, who pleaded guilty in July 2022 in Wood County Common Pleas Court to a felony count of theft in office. She was sentenced August 2022 to five years of community control and ordered to make restitution totaling \$39,272.50, which included \$18,306.50 in audit costs.

The Auditor of State's Special Investigations Unit (SIU) received a complaint in September 2019 after the new Risingsun fiscal officer found discrepancies in the Village's financial records, including cash withdrawals made by Hindall from two accounts.

SIU identified four schemes Hindall perpetuated for her own benefit from Nov. 1, 2017, through June 30, 2019, including improper cash withdrawals totaling \$21,087; donations totaling \$2,500 that were not deposited into the Village's bank account; \$718 in improper gross wages, vacation, and compensatory time payments to herself; and \$400 in stolen park rental receipts.

Risingsun Mayor Rick Whetsel and his bonding company are jointly and severally liable for the \$718 in improper payroll, as Whetsel was responsible for oversight of Hindall's timesheets.

Re: Reforms to ERIC Bylaws & Membership Agreement

Dear Mr. Hamlin and ERIC Board Members:

Ohio joined ERIC in 2016, prior to the start of my administration. Since then, I've found this collaborative partnership between member states to be the only advanced election integrity resource of its kind. Ohio's participation in ERIC has helped to identify hundreds of cases of apparent voter fraud that have been referred for investigation and potential prosecution. Each of these cases of wrongdoing, if accurate, represent the potential to alter or spoil local, state, and even federal elections impacting thousands of Ohioans, particularly in close contests. The value that our ERIC membership provides in fulling my duty to investigate, as state law requires, "the administration of election laws, frauds, and irregularities" has been tangible.

That's not to say ERIC is without its flaws. From its inception, the organization has maintained questionable ties to ex-officio board members with highly partisan reputations. While most member states tolerated this association, the ongoing presence and influence of these polarizing figures has become a distraction, if not a deterrent, to long-overdue reforms to ERIC's governing documents. As a result, several member states have already left the organization, and others are considering that step pending the outcome of another vote on the proposed reforms at ERIC's March 17, 2023 meeting.

Eight months ago, Ohio convened a bipartisan working group of ERIC board members to address legitimate concerns expressed by dues-paying members, including membership requirements, operational and financial integrity, and bipartisan oversight. Unfortunately, the working group's previously unanimous recommendations were stifled at the February 19, 2023 meeting by an ex-officio board member's aggressive lobbying campaign. ERIC board members participating in that meeting have since expressed dismay that the rushed and chaotic vote taken at the conclusion of the meeting did not comply with the rules of order and may therefore be illegitimate. Sadly, this outcome only reinforces the concerns dues-paying members have raised and exacerbates the rapidly degrading public view of the organization. The working group's proposals would have addressed and sought to remedy these alarms.

I have been a hopeful advocate for the value of ERIC and a champion for the reforms I and others believe could save it, but the organization's obstinance may be its demise. As I write this letter, at least six of my colleagues are considering a withdrawal from ERIC. The immediate action of the ERIC board at its March 17 meeting can potentially salvage their participation and ours, but ONLY if the proposed reforms win the approval the board. These include:

- Amending the bylaws to explicitly state that ERIC's membership should only consist
  of member states, who answer to the voters and taxpayers they represent,
- 2. Removing ex-officio membership positions from ERIC's bylaws, and
- 3. Permitting member states to utilize ERIC's data-sharing services "a la carte," in the manner which they believe best serves their local interests. For example, members should not be forced to meet specific requirements, such as Eligible but Unregistered voter mailings or cross-state fraud analysis, if they do not deem those actions necessary or relevant to the needs of their respective states.

Other reforms are needed to improve ERIC's reputation and accountability, but these fundamental changes must take place at the March 17 meeting to prevent any further erosion of support. I want to emphatically state that Ohio remains in constant discussion with fellow member states about the future of ERIC, and I will not accept the status quo as an outcome of the next meeting. Anything short of the reforms mentioned above will result in action up to an including our withdrawal from membership. I implore you to do the right thing.

Re: Notice of Resignation from ERIC

Dear Mr. Hamlin and ERIC Board Members:

I am hereby notifying you of Ohio's resignation from the Electronic Registration Information
Center (ERIC), effective 91 days from the date of this letter as stated in the bylaws. This decision
does not come without careful thought and extensive conversations with my counterparts in the
organization. The action Ohio is taking today follows nearly a year of good faith, bipartisan
efforts to reform ERIC's oversight and services. Unfortunately, these attempts to save what
could be an unparalleled election integrity service have fallen short.

ERIC has chosen repeatedly to ignore demands to embrace reforms that would bolster confidence in its performance, encourage growth in its membership, and ensure not only its present stability but also its durability. Rather, you have chosen to double-down on poor strategic decisions, which have only resulted in the transformation of a previously bipartisan organization to one that appears to favor only the interests of one political party. I believe the current actions and inactions of ERIC will effectively set in motion its demise.

As stated in my March 6, 2023 letter: [T]he immediate action of the ERIC board at its March 17 meeting can potentially salvage their participation and ours, but ONLY if the proposed reforms win the approval of the board. These include:

- Amending the bylaws to explicitly state that ERIC's membership should only
  consist of member states, who answer to the voters and taxpayers they represent,
- 2. Removing ex-officio membership positions from ERIC's bylaws, and
- 3. Permitting member states to utilize ERIC's data-sharing services 'a la carte,' in the manner which they believe best serves their local interests. For example, members should not be forced to meet specific requirements, such as Eligible but Unregistered voter mailings or cross-state fraud analysis, if they do not deem those actions necessary or relevant to the needs of their respective states.

Unfortunately, you chose to stifle action on these proposed reforms through questionable tactics at the board's February meeting and again today through a selective and overly aggressive enforcement of ERIC's bylaws. We fundamentally disagree with the legal interpretation that every member of ERIC, whether they have resigned or not, must waive notice to offer a proposed amendment for consideration – especially after the proposed amendment was previously noticed and voted on. One must ask what reasons motivated the author of the governing documents to intentionally draft them to be so restrictive and difficult to amend. Nonetheless, my staff solely took the initiative to comply with this onerous interpretation and achieved some of the reforms, while the rest were rejected.

I cannot justify the use of Ohio's tax dollars for an organization that seems intent on rejecting meaningful accountability, publicly maligning my motives, and waging a relentless campaign of misinformation about this effort. The conduct of ERIC and some of its hyper-partisan allies in recent weeks only heightens my suspicion and reinforces my decision. Additionally, I cannot accept the board's refusal – for a third time – to adopt basic reforms to the use of ERIC's datasharing services. I fundamentally believe that every dues-paying ERIC member should have the right to use these services in the best interest of their own state and its taxpayers. This should be a non-controversial policy, yet you have chosen to make it a hyperbolic, partisan fight that has fractured an organization that had so much potential for good.

As every past and present member of ERIC knows, I have been a hopeful advocate for reform.

You had every chance to deliver it, but you chose not to act. Therefore, you have left me with no choice but to look for a more accountable alternative.

#### **OUR CONGRESSMAN IS WORKING FOR US**

#### Friends,

At the end of last week, President Biden submitted his Fiscal Year (FY) 2024 budget to Congress. Unfortunately, his budget contains tax hikes and budget gimmicks that would only make the cost of living higher for Americans. It does not address the unsustainable fiscal trajectory our country is on, which has only been made worse by the out-of-control government spending we've experienced under the Biden Administration.

As a member of the House Appropriations Committee, I have the privilege to carefully scrutinize the Administration's budget request each year. It is my hope that my colleagues in Congress from both sides of the aisle, will work together to produce a responsible and productive budget for FY 2024. #### Relaunching the Addiction, Treatment, and Recovery Caucus

Earlier in the week, I joined Congressman Paul Tonko (NY-20) in relaunching the Addiction, Treatment, and Recovery Caucus for the 118th Congress. We will serve as Co-Chairmen of the Caucus, which brings together a bipartisan group of 50 Members of Congress from both sides of the aisle who are unified by a commitment to helping address our nation's addiction crisis. Specifically, the caucus will work to expand access to treatment for addiction, support Americans in recovery, and bolster the health workforce on the frontlines.

Sadly, the ongoing opioid epidemic continues to wreak havoc in communities throughout Ohio and across our nation. Ohio is one of the top five states with the highest rates of fatal-opioid-related overdoses. Here in Congress, we have a responsibility to take more action and find ways to support Americans suffering from addiction. In my new role as Co-Chairman of the Caucus, I look forward to facilitating challenging, yet very necessary conversations in Washington to find bipartisan solutions that expand access to treatment and destignatize addiction for Americans. I remain committed to tackling this crisis and supporting legislation in the House that will have a real impact.



#### Ensuring Northeast Ohio Remains on the Frontlines of Manufacturing

Earlier this week, I met with the President of LG to discuss their manufacturing footprint in Northeast Ohio and the importance of training the next generation of high skill workers. Ohio's 14<sup>th</sup> Congressional District is home to the Ultium Cells LLC Battery Plant. Ultium began producing batteries at its manufacturing facility located in Warren, Ohio in August 2022. Once the plant is running at full capacity it will support approximately 1,300 high-tech jobs.

We are lucky to have a variety of manufacturers across the district; this facility will help ensure
Northeast Ohio remains on the frontlines of the transportation manufacturing supply chain. I'm proud to represent a district with innovative manufacturing companies like LG, and I hope to see this new plant, and its employees, thrive in our community.



#### PARTICIPATING IN THE FSGG APPROPRIATIONS SUBCOMMITTEE HEARING

On Thursday, I participated in the Financial Services and General Government Appropriations Subcommittee's Hearing to discuss President Biden's FY 2024 budget request and overall outlook for the U.S. economy. We heard from Department of Treasury Secretary Janet Yellen and Office of Management and Budget Director Shalanda Young.

During the hearing, I had the chance to question Secretary Yellen on environmental, social, and governance (ESG) regulations put in place by the European Union (EU) which will harm U.S. businesses. As a member of the House Appropriations Committee, I will continue to push our Administration to better negotiate with foreign governments on behalf of American industry. Additionally, I will continue to work with my colleagues here in Congress to hold the Administration accountable and push for responsible fiscal reform.



#### SERVING AS CO-CHAIR OF THE HOUSE MANUFACTURING CAUCUS

Lastly, I'm pleased to announce I am joining Congresswoman Haley Stevens as Co-Chair of the House Manufacturing Caucus, which will work to educate and amplify the voices of U.S. manufacturers in Congress. #### LEGISLATIVE UPDATES

COLUMBUS – *State Representatives Nick Santucci (R-Howland Twp.)* and Adam Mathews (R-Lebanon) this week introduced legislation that would modify income tax deductions for contributions to 529 plans and STABLE accounts, which are investment accounts available to eligible individuals with disabilities. They allow individuals with disabilities to save and invest money without losing eligibility for certain public benefits programs, like Medicaid, SSI, or SSDI.

Currently, single tax filers can claim a \$4,000 deduction, and married, joint tax filers can also claim only a \$4,000 deduction. This bill will raise the deduction limit to \$8,000 to account for a second person.

"This legislation will ensure Ohioans with disabilities are not penalized for being good stewards of their finances," Santucci said. "This common-sense policy will help support our citizens in need."

In addition to increasing the maximum tax deduction maximum for joint filers, this legislation indexes these deductions to account for inflation.

The measure now awaits official committee assignment.





COLUMBUS – *State Representatives Nick Santucci (R-Howland Twp.)* and Melanie Miller (R-City of Ashland) this week introduced the Baby Products Tax Exemption Bill, which exempts certain baby products from the sales and use tax.

"Eliminating the sales tax on these necessities will help ease the financial burden on Ohio families raising children," Santucci said.

The bill proposes to create a sales and use tax exemption for certain baby products, including children's diapers, car seats, cribs, strollers, baby carriers, and baby monitors. The exemption will ease the financial burden on Ohio families raising children.

Additionally, the elimination of sales tax on these products will help ensure that Ohio families have access to the essential items necessary for the health and well-being of their children.

"I want to make Ohio the number one state in America to raise a family," Santucci added. "This pro-family bill will help keep young families in Ohio and reduce costs for parents hammered by inflation over the past two years."

The measure now awaits official committee assignment.



#### Matt Dolan Launches "Blind Loyalty Brown" Digital Ad Campaign

Cleveland, OH: U.S. Senate candidate Matt Dolan launched a digital ad campaign Thursday highlighting Sherrod Brown's blind loyalty to his party. Despite the recent assertions of left-wing PACs and Ohio Democrats, analysts have found that Brown votes with Joe Biden 98.5% of the time. The ad campaign, running on digital platforms, calls on Ohio voters to visit BlindLoyaltyBrown.com and sign a petition to "send a message to Sherrod Brown's liberal, out-of-state allies that anyone who votes with Joe Biden more than 98% of the time is no 'independent."

"Liberal PACs and partisan left-wing organizations are smearing me and fellow conservatives in Ohio because they cannot defend Sherrod Brown's liberal record. They claim there's no proof that Sherrod Brown is blindly loyal to his party. Well, we have the receipts," **Matt Dolan** said. "For years, Sherrod Brown has said one thing to Ohioans and then voted against our interests in the U.S. Senate. He claims to be a champion of workers, but he votes in lockstep with Joe Biden more than 98% of the time to undermine the national security of our nation and the financial security of working families. On Feb. 8, Welcome PAC, a liberal special interest group organized and funded from outside Ohio, attacked Matt Dolan in a <u>Columbus Dispatch op-ed.</u> In it, they describe Sherrod Brown as an "independent Democrat," and said that there was no proof that Sherrod Brown had "blind loyalty" to his party.



#### **Parental Rights Bills Advance Across the Nation**

WASHINGTON / March 28, 2023 – In a historic move, the U.S. House of Representatives passed H.R. 5, the Parents Bill of Rights Act this past Friday. The bill requires schools to notify parents of their rights regarding the education of their children, including the rights to review the curriculum, meet with teachers, inspect the books, and more. Long-time observers say this is the first parental rights bill that has been ever approved by the House of Representatives.

Thus far in 2023, parental rights bills have been introduced in 25 states across the country. In some states, two or more parental rights bills are under consideration:

These bills reveal how parental rights has become a hot-button issue as growing numbers of parents from across the political spectrum express alarm over policies that allow schools to promote sexually charged agendas to students. Many of these policies are based on controversial interpretations of the federal Title IX law, which was originally intended to stop sex discrimination in schools.
