Loychik Appointed as Chair of House Armed **Services Committee**

COLUMBUS, OH – State Rep. Mike Loychik (R-Bazetta) announces he has been appointed by Ohio House Speaker Jason Stephens (R-Kitts Hill) as Chair of the House Armed Services Committee for the 135th General Assembly.

Ohio Secretary of State Week in Review

Helping Pennsylvania Follow Ohio's Example

Ohio Secretary of State Frank LaRose offered testimony on Monday to the Pennsylvania House Republican Policy Committee, providing insight on the proper implementation of election laws requiring voters to show photo identification.

The Pennsylvania state legislature sought the advice of Secretary LaRose as they seek to implement a similar model to the one adopted by the Ohio General Assembly last year (HB 458), which requires a photo ID to vote while also providing voters with a free state ID card and allows those who forget their ID to cast a provisional ballot.

Secretary LaRose also offered testimony to the Pennsylvania state legislature after the 2020 election, advising lawmakers on election administration and security measures that worked well in Ohio. He continues to consult other states on various election improvement strategies.



No, voting a provisional ballot does not mean your vote will not count.

A provisional ballot is used to record a vote if a voter's eligibility is in question and the voter would otherwise not be permitted to vote at his or her polling place. The content of a provisional ballot is no different from a regular ballot, but it is cast "provisionally" until election officials can verify the voter's eligibility to vote in the particular precinct at that election.


Any of the following scenarios would require you to cast a provisional ballot on Election Day:

Your name does not appear on the official poll list for that precinct, or an election official assert that you are not eligible to vote or is unable to determine your eligibility;

- You are unable to provide or do not have the required proof of identity;
- Your name appears on the official poll list for that precinct as having already requested an absentee ballot;
- Your name is marked on the poll list or signature book with a notation that certain registration mailings have been returned as undeliverable;
- Your voter registration has been challenged and/or a hearing on a challenge to your eligibility as an elector has been postponed until after Election Day; or
- Your signature, in the opinion of the precinct officers, does not match the signature on your registration form.

SCAMS TARGETING OHIOANS



Computer Repair Scams

An "employee" of a computer company contacts you claiming your computer has a virus and offers to "fix the problem." The person asks for access to your computer, which allows the scammer to install malicious software designed to scan your computer for personal information or to lock your computer so that you cannot use it until you pay a "ransom" to unlock it.

Fake Check Scams

Someone sends you a check or money order and asks you to deposit it in your account and wire-transfer back the money, minus a nice bonus for you — a "thank you" for helping. Regardless of the pitch, the result is the same: The check or money order you received is counterfeit; it will be returned to your bank unpaid, and the full amount will be deducted from your account.

Phishing and Spoofing

Scammers use clever emails, websites, phone calls and text messages to "phish" for information by posing as a legitimate business. Never give personal information to someone who contacts you unexpectedly, even if they say they are from a trusted business, such as your bank. Scammers can use "spoofing" to disguise the phone number that appears on your caller ID to make their ploys seem more legitimate.

Romance Scams

A con artist meets a victim online or over the phone and claims to be temporarily located overseas — perhaps due to a military assignment or mission trip. After developing a relationship, the scammer eventually asks the victim to send money to pay for airfare, medical expenses or military fees. In reality, there was never "true love," and any money sent will be lost

Home Improvement Scams

Door-to-door contactors offer to repair your roof, pave your driveway or trim your trees for a great price. After you pay, the contractor disappears after doing a poor job or no work at all. Never pay in full upfront. If you are solicited at your home, you have three days to cancel the contract, and the work should not begin within that period.

Grandparent Scam

A con artist poses as your grandchild, claims to be in trouble and asks you to send money via wire transfer or prepaid card. If you're suspicious, ask a question only a family member would know how to answer, also, call your son or daughter to confirm the claim.

Sweepstakes Scams

Someone falsely claims that you have won the lottery or a contest that you never entered. All you need to do to collect the winnings is prepay a fee or a tax. However, your winnings will never arrive because the lottery or contest is take. Legitimate sweepstakes are free and require no upfront payment.

Phony Charities

Scammers invent fake charities. To verify the legitimacy of a charitable group before making a donation, call the Ohio Attorney General's Help Center at **800-282-0515**.

Tips for

AVOIDING SCAMS

ALWAYS:

- Be skeptical when someone requests immediate payment via wire transfer, prepaid money card or gift card.
- Research businesses and charities through the Ohio Attorney General's Office and the Better Business Bureau.
- » Beware of strangers who seek new, quick, personal connections with you or a loved one.
- » Get all verbal promises in writing and review contracts.
- Keep your personal information private and shred outdated documents containing such information.

NEVER:

- Send money via wire transfer, gift card or prepaid credit card to a stranger.
- » Give personal information to someone who has contacted you unexpectedly.
- » Carry unnecessary personal information, such as your Social Security card, in your wallet or purse.
- Pay to win a prize or sweepstakes.
- » Allow someone "remote access" to your computer.
- Pay the full amount upfront before any work has been done.

OTHER SMART STEPS

 Use a credit card, rather than a debit card, cash or check. The Fair Credit Billing Act offers certain protections that other payment methods don't.

For transactions involving a lot of money completed by phone or via the internet, keep a log of who you spoke with and when, the person's contact information and any money paid.

Check your credit report(s) at least once a year at www.annualcreditreport. com or by calling 877-322-8228. If you notice unfamiliar accounts, contact the three major credit reporting agencies (Experian, Equifax and TransUnion). Also, contact the Ohio Attorney General's Identity Theft Unit at 800-282-0515.

JOYCE APPOINTED AS CHAIRMAN OF THE HOUSE APPROPRIATIONS SUBCOMMITTEE ON HOMELAND SECURITY

Jan 17, 2023

WASHINGTON, DC – Today, Congressman Dave Joyce (OH-14) was appointed as the Chairman of the House Appropriations Subcommittee on Homeland Security.

"I thank Chair Granger and my colleagues on the Steering Committee for trusting me with this responsibility," **said Joyce.** "The Appropriations Committee plays an important oversight role and with Republicans back in charge of the House, the Department of Homeland Security (DHS) and its duties in securing our nation will no longer be overlooked. Each day, our brave Customs and Border Protection agents are faced with increased challenges to secure our nation's borders, stop illegal crossings, and prevent illicit substances, such as fentanyl, from flowing into our country. While we must increase focus on securing our Southern Border, we must also address the critical needs of every DHS component responsible for protecting the American people, including the Federal Emergency Management Agency. I look forward to working with my colleagues in Congress to ensure the Department receives the necessary funds and oversight to keep our homeland safe and effectively carry out its mission."

On Congressman Joyce's appointment, Chair Granger said: "Congressman Joyce has always fought hard for northeast Ohio and worked tirelessly to deliver on its needs. He has been a committed Member of the House Appropriations Committee, and I know his dedication to the American people will continue in his new role on the Homeland Security Subcommittee. I look forward to working with him in this capacity."

This announcement follows an ongoing and tireless commitment by Congressman Joyce to address the crisis at our Southern Border. In the 117th Congress, the House <u>Unanimously passed</u> Joyce's bipartisan legislation to protect Customs and Border Protection agents from fentanyl. Additionally, in the 117th Congress, Congressman Joyce introduced the bipartisan <u>Advanced Border Coordination Act</u> to create Joint Operation Centers along the southern border to serve as centralized operating hubs tasked with coordinating border operations, information sharing, and workforce training.

JOYCE, BROWN, TURNER, AND ROSS RE-INTRODUCE BIPARTISAN BILL TO SUPPORT POLICE, FIRST RESPONDERS STRUGGLING WITH PTSD

WASHINGTON, DC – Today, Congressman Dave Joyce (OH-14), introduced *the Fighting Post-Traumatic Stress Disorder Act of 2023* with Congresswoman Shontel Brown (OH-11), Congressman Mike Turner (OH-10) and Congresswoman Deborah Ross (NC-02). The bipartisan, bicameral legislation aims to combat the rising rates of Post-Traumatic Stress Disorder (PTSD) amongst first responders and to address the long term mental health consequences associated with PTSD. Senators Chuck Grassley (R-IA) and Chris Coons (D-DE) have introduced companion legislation and are leading the effort in the United States Senate.

"When danger strikes, our first responders bravely show up without hesitation to handle any situation they are thrown into," **said Congressman Joyce.** "Unfortunately, when our first responders are off the clock, the stress and pressures associated with their jobs often do not leave them. It is time Congress does more to help our dedicated emergency personnel and provide them with the resources they need to cope with their job's extreme pressures and help the countless emergency personnel suffering from PTSD. I thank my colleagues for joining me on this bicameral, bipartisan legislation and encourage other members to join us in this cause."

"It is long past time we addressed the impact protecting our communities often has on our public safety officers," **said Rep. Brown**. "Police officers and first responders often suffer invisible wounds as they put their lives on the line and cope with traumatic situations while protecting our communities. This bipartisan legislation will ensure that our public safety officers have access to the mental health services they need to continue serving and protecting our neighborhoods in Northeast Ohio."

"This bipartisan legislation will make vital mental health resources available to our law enforcement officers. The men and women who wear the uniform risk their personal safety each day to keep our communities safe. It is our responsibility in return to ensure they have the resources needed to support them," said Congressman Turner

"Our first responders and law enforcement officers put themselves in harm's way every day to keep our communities safe," **said Congresswoman Deborah Ross.** "They often face dangerous and stressful situations while on the job, resulting in higher rates of post-traumatic stress disorder and related mental illnesses than in the general population. This bipartisan bill ensures that our public servants who risk their lives for us have access to the life-saving resources and care they need to stay healthy and continue protecting communities in North Carolina and across the country."

"On behalf of our over 1,800 members, the Ohio Fire Chiefs' Association is honored to lend our support to the 'Fighting Post-Traumatic Stress Disorder Act of 2023'. Everyday brave men and women from across our nation put themselves on the frontline knowing that their chances of batting PTSD are greater than other professions. We must do whatever we can to treat, and hopefully prevent, PTSD from occurring. We are honored to work with our national leaders to advance this important initiative," said **Chief Colin Altman, Ohio Fire Chiefs' Association President.**

Post-Traumatic Stress Disorder disproportionally affects first responders. According to the Institute of Health, one in three first responders will develop PTSD compared to one in five Americans within the general population. When undiagnosed or left untreated, PTSD leads to higher rates of anxiety and depression, substance and alcohol abuse, and an increase in suicidal ideations.

To address this growing crisis, this bill directs the Attorney General to develop evidence-based programs that will be made available to public safety officers across our country to treat and address PTSD. In crafting these proposals, the Attorney General must engage and consult with local, state, and federal agencies that employ first responders and non-governmental organizations that advocate on their behalf. Once these proposals are drafted, they will be submitted to Congress for formal consideration.
