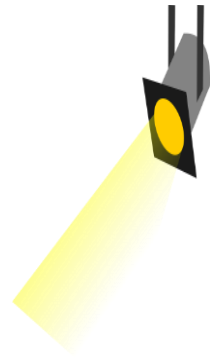

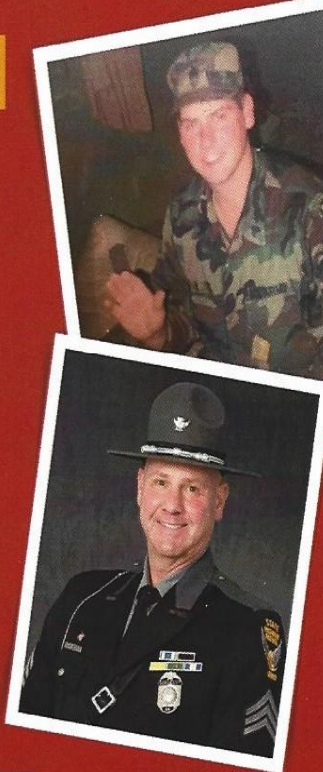

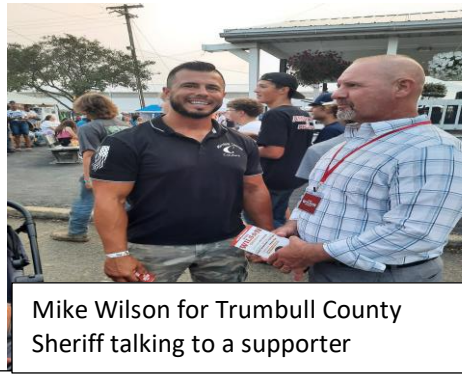

# PROTECT OUR CONSTITUTION



## DON'T LISTEN TO THE MEDIA AND THE HYPOCRISY FROM THE DEMOCRATS.

“The constitution establishes the nature and character of the state government. It organizes government into various branches, prescribes their powers, and specifies the extent to which these powers may be exercised.”

### Does Issue 1 make it harder to pass laws in Ohio?

(Answer: No!)

- Issue 1 only impacts Constitutional Amendments, which are being targeted by certain outside interest groups.
- Instead of following the normal process when they cannot get their agendas passed, they try to amend the Constitution because it is one of the easiest in the nation to change.
- The normal legislative process for passing laws/statutes **does not change** – your vote and your legislator’s vote still counts the same way.

### How is a Constitutional Amendment different from a normal statute/law passed by the Ohio Legislature?

- The Ohio Constitution is a “foundational document” – **it was not intended as a way to pass new laws to satisfy a political whim!** The Founding Fathers meant for changes to require a supermajority as these establish the guidelines for the law.
- Normal laws (criminal laws, property law, contract law...), will follow the same procedures as before. **Issue 1 does not impact the process for how normal laws are passed in Ohio.**
- The Ohio Constitution has been amended 172 times versus the U.S. Constitution only 27 times. Changes are getting into our Constitution (establishment of casinos, livestock care standards, etc.) that do not belong at that level.
- Remember – Changes to law should go through the proper and normal legislative process, not enshrined into the Ohio Constitution.

### Why is this needed for Ohio?

- **Protect the Ohio Constitution:** Our state constitution already has **9 times** as much text than the entire U.S. Constitution because Ohio is one of a handful of states in the U.S. which allows constitutional changes so easily (50% + 1). To amend the United States Constitution, you must first have the vote of 2/3 of both the United States House of Representatives and the United States Senate **plus** 75% (37 out of 50) state legislatures to ratify.
- **Most states** do not allow voters to propose or ratify amendments ever – they must go through the normal legislative process. **HOWEVER, RADICAL GROUPS HAVE LEARNED THEY CAN BYPASS THE NORMAL PROCESS** since Ohio is an easy target because of how easy it is to amend the constitution compared to most other states. This was not the intent of how our constitution was to be utilized!
- **Ensure All Counties are Represented:** Issue 1 will require that petitions to amend the Constitution must come from all 88 counties. Today only half (44 out of 88) of the counties need to be involved in the process. Ohio citizens should be fully represented rather than allowing targeting of only counties favorable to a particular agenda.

### What Does the Actual Ballot Language Do?

Issue 1 elevates the standards for future amendments to the Ohio Constitution, after January 1, 2024:

- Raises the threshold for proposed Constitutional amendment placed on a statewide ballot from simple majority (50%+1) for approval to **60% of the vote** (closer to what the U.S. Constitution requires)
- Raises the threshold for petitions for such proposals to **require signatures from voters in ALL 88 counties** (currently only 44 of 88 counties required, allowing groups to “target” counties aligned with their agenda)
- Ensure that all valid signatures for a proposed Constitutional amendment be submitted on the specified due date, and that additional signatures cannot be submitted after the deadline.

### Why is the timing of this change so important?

- **Both Democrat and Republican groups have tried to put similar changes on the ballot in the past, but they didn’t have enough support to get them through. Now there are upcoming proposals which are being untruthfully marketed and timing has become critical.**
- **Radical special interest groups are ramping up plans to bypass the normal legislative process and pass Constitutional Amendments instead.**

## HOUSE PASSES FY24 AVIATION REAUTHORIZATION BILL WITH JOYCE PRIORITIES

**WASHINGTON, D.C.** –Yesterday, Congressman Dave Joyce (OH-14) voted in favor of H.R. 3935, the Securing Growth and Robust Leadership in American Aviation (SGRLAA) Act which reauthorizes funding for Federal Aviation Administration (FAA) programs, as well as aviation safety and infrastructure programs for the next five years.

The FY24 FAA reauthorization contains Congressman Joyce’s amendment that would designate the Youngstown-Warren Regional Airport (YNG) and Youngstown Air Reserve Station (YARS) as a primary airport. Currently, YNG is the only commercial airport in the country with an Air Reserve Station that does not have commercial air service. Upon the loss of commercial air service in 2018, the FAA significantly reduced the annual maintenance funding at the airfield. Earlier this year, Representatives Dave Joyce (OH-14) and Bill Johnson (OH-06) introduced standalone legislation in the U.S. House of Representatives to designate **YNG/YARS as a primary airport.**

**“With travel returning to pre-pandemic levels, flight delays and cancellations continue to inconvenience travelers across the country,”** said Congressman Joyce. **“I am proud to support this bill to advance the performance of the FAA, grow the aviation workforce, invest in airport infrastructure, and improve passenger experience. This legislation is a critical to continue America’s global leadership in aviation and will have a direct benefit for communities across Northeast Ohio.”**

In addition to Joyce’s amendment, the FY24 FAA reauthorization:

- Provides long-term stability across the Nation’s aviation system and encourages aviation innovation;
- Restructures the FAA to improve efficiency;
- Reestablishes the Aviation Workforce Development (AWD) grant program to attract pilots and mechanics and extending it to manufacturers as well. The program is funded at \$45 million per year for two years;
- Authorizes and strengthens the National Transportation Safety Board;
- Makes targeted investments in airport infrastructure across the nation by authorizing \$4 billion in funding per year for the Airport Improvement Program (AIP), split between primary and non-primary airports.



An informational meeting was held by the Trumbull County Republican Party on Thursday, July 20<sup>th</sup> at the Warren Trumbull Public Library. **ELEVATING THE STANDARDS TO QUALIFY FOR AN INITIATED CONSTITUTIONAL AMENDMENT AND TO PASS A CONSTITUTIONAL AMENDMENT**

**Proposed by Joint Resolution of the General Assembly**

**To amend Sections 1b, 1e, and 1g of Article II and Sections 1 and 3 of Article XVI of the Constitution of the State of Ohio**

A majority yes vote is necessary for the amendment to pass.

The proposed amendment would:

- Require that any proposed amendment to the Constitution of the State of Ohio receive the approval of at least 60 percent of eligible voters voting on the proposed amendment.
- Require that any initiative petition filed on or after January 1, 2024 with the Secretary of State proposing to amend the Constitution of the State of Ohio be signed by at least five percent of the electors of each county based on the total vote in the county for governor in the last preceding election.
- Specify that additional signatures may not be added to an initiative petition proposing to amend the Constitution of the State of Ohio that is filed with the Secretary of State on or after January 1, 2024 proposing to amend the Constitution of the State of Ohio.

If passed, the amendment will be effective immediately.

## LEGISLATIVE UPDATE

### **THE 64<sup>TH</sup> HOUSE DISTRICT**

Below is a short description of legislation I have been working on to help my constituents and the people of Ohio. #### **COMMUNITY CONNECTORS WORKFORCE PROGRAM – HB71**

A program that seeks to encourage young adults and students to work and create an emphasis on soft-skill training in Ohio schools.

#### **FLAGS FROM U.S. ACT – HB 87**

This bill would prohibit state agencies and political subdivisions from using public funds to purchase a U.S. or Ohio flag that was not made in the United States.

#### **SAVE OHIO SAFE RX ACT – HB 92**

Requires the State Board of Pharmacy to develop a program for the importation of prescription drugs from Canada, in an effort to provide cost savings for Ohioans.

#### **NONPROFIT WORKFOCE REINVESTMENT ACT – HB 108**

Allows tax-exempt retailers to be certified by the Director of Development, so they may retain a portion of the states sales tax they collect on sales of donated goods to fund certain job training and placement services.

#### **BABY PRODUCTS TAX EXEMPTION – HB 118**

The bill proposes to create a sales and use tax exemption for certain baby products, including diapers, car seats, cribs, strollers, baby carriers and baby monitors.

#### **TAX RELIEF FOR THE DISABLED – HB 125**

Legislation that would modify income tax deductions for contributions to 529 Plans and STABLE accounts, which are investment accounts available to eligible individuals with disabilities.

#### **ENDING UNETHICAL INSURANCE PRACTICES – HB 160**

Ending the practice of artificial capping of fees by insurance companies in the dental industry.

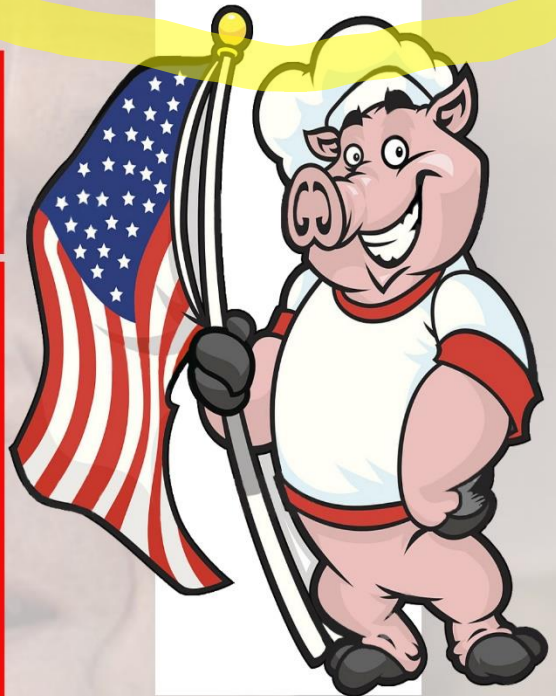
