



As Attorney General, he will continue this pursuit, fighting to protect Ohio families, and combating our state's opioid epidemic.

He and his wife, Darlene, make their home in Franklin County, and have three grown children and four grandchildren. When not in the arena, Dave makes music with his children and friends, watches Buckeye football and resists the urge to eat peanut butter ice cream.

LOYCHIK ANNOUNCES FUNDING TO REDUCE CRIME IN TRUMBULL COUNTY

State Rep. Mike Loychik (R-Bazetta) announces significant funding for the Trumbull County Prosecutor's Office to help reduce violent crime throughout the community. The funding stems from the Ohio Violent Crime Reduction Grant Program.

"I have been an adamant supporter of our law enforcement who keeps our families and residents safe," Loychik said. "These dollars will be put to good use by enhancing the safety and protection of our communities throughout Trumbull County."

Loychik supported House Bill 110, the state operating budget, which is funding the program to assist local law enforcement in finding solutions to reduce violent crime. The program funding will help the department in recruiting new officers, maintaining staffing levels and providing various assistance to prevent violent crime.

The Trumbull County Prosecutor's Office is set to receive \$495,151 through the grant program.

Overall, the program will be awarding a total of \$58 million across the state. This most recent round of funding awarded \$5.7 million to 16 local and state law enforcement agencies, including the Trumbull County Prosecutor's Office.

SUBSTITUTE HOUSE BILL 492 CLEARS OHIO HOUSE

COLUMBUS – State Representative Mike Loychik (R-Bazetta) today announced that Substitute House Bill 492 has passed the Ohio House and will next head to the Ohio Senate for further consideration.

This legislation was crafted to require coaches to complete a student mental health training course that has been certified by the Department of Mental Health as a requirement to renew their coaching permit.

"This legislation is a step in the right direction and will ensure that coaches have the training needed to help identify it and know what to do should any of their students have mental health troubles," said Loychik.

Mental health is just as vital to a student's wellbeing as their physical health and this legislation will work to improve the mental health of children throughout Ohio. This training will help both coaches and students alike.

TIM RYAN PLEDGED TO SUPPORT TAXPAYER-FUNDED GENDER REASSIGNMENT SURGERY FOR ILLEGAL IMMIGRANTS

Ohio Democratic Senate candidate Rep. Tim Ryan pledged to support taxpayer-funded gender reassignment surgeries for incarcerated Americans and illegal immigrants during his unsuccessful bid for president.

Ryan's commitment came in a 2019 <u>presidential candidate questionnaire</u> from the American Civil Liberties Union (ACLU).

Asked whether he would use his "executive authority to ensure that transgender and non-binary people who rely on the state for medical care – including those in prison and immigration detention – will have access to comprehensive treatment associated with gender transition, including all necessary surgical care," Ryan stated "yes."

The questionnaire asked the candidates who marked yes to explain their rationale, but Ryan did not offer additional insight.

In addition, the questionnaire also asked the candidates whether they would commit to reducing "the size of the <u>immigration detention</u> system by at least 75%, including by: 1) cutting ICE's detention budget; 2) ending the detention of families, asylum seekers, and other vulnerable populations; 3) ending prolonged detention without bond hearings; and 4) ending requirements that immigrants post bonds they cannot afford."

Again, Ryan checked the box indicating "yes."

Ryan also committed at that time to support "ending the use of ICE detainers," which, according to the Immigration and Customs Enforcement website, are notices issued by the Department of Homeland Security to "federal, state and local law enforcement agencies (LEAs) to inform the LEA that ICE intends to assume custody of an individual in the LEA's custody."

In a statement to Fox News Digital, the Vance campaign said Ryan's commitment to the funding of gender reassignment surgeries for illegal immigrants is a "radical" position.

"Taxpayer-funded gender reassignment surgeries for illegal immigrants: you really cannot get more radical than that," a Vance campaign spokesperson said. "Tim Ryan has spent this entire campaign lying to Ohioans about his record and trying to convince them he's a moderate. The truth is that he's just a far-left, woke liberal who wants to waste taxpayer money on insane ideas like this. He doesn't belong anywhere near the U.S. Senate."



In 2020, Nick replicated this success and secured an additional \$1.25 million to help Weathersfield Police combat the opioid crisis, provide training resources for Valley firefighters through the Mahoning County Career and Technical Center, renovate Stambaugh Auditorium, and support OH Wow! Children's Center.
